Notice of Temporary Special Benefit for Households Who Are Exempt from Resident Tax for Fiscal Year 2024

- This notice is to inform that, in order to provide financial support to those low-income households whose finances are affected by price increases, 30,000 yen will be provided per household to those who are exempt from resident tax for fiscal year 2024, and 20.000 ven per child will be provided to such households in which there are any children 18 years old or younger (born on or after April 2, 2006) as of the base date of December 13, 2024.
- Eligible households are those who meet all of the following requirements:
- (1) Households who are registered as residents in Yokkaichi City as of the base date of December 13, 2024
- (2) All household members are exempt from resident tax for fiscal year 2024 and have no unreported income that is subject to resident tax.
- (3) No household members are the dependent of any person who pays resident tax.
- (4) No one in your household has a reported exemption from resident tax based on a tax treaty.
- (5) No one in your household has received the same benefits from any other municipality.
- * If you do not meet any of the above requirements, you will not be eligible to receive the benefit. Therefore, please notify us by 17:00, April 7, 2025 (Mon.).
- . The details of the account for which the benefit is to be credited, the amount of benefit, and the persons eligible to receive the benefit are shown on the left.
- The benefit will be credited to the account, described on the left, which is the same account to which the previous temporary special benefit for households exempt from resident tax was credited. Please note that, if the account has been closed or the account holder has changed, the benefit cannot be credited on the benefit payment date below.
- Those children born between the base date of December 13, 2024 and June 13, 2025 (inclusive) may be eligible to receive the additional benefit for children. Thus, please notify us by 17:00. June 30, 2025 (Mon.).

Benefit payment date: April 17, 2025 (Thu.) (scheduled)

Please note that the time at which the benefit will be credited to your account on the benefit payment date may differ depending on the financial institution.
